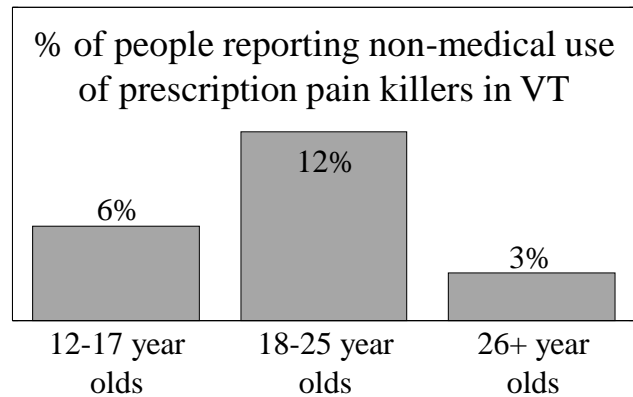


Concerned about Opiate Addiction?

How to get treatment for yourself or someone you care about...

Help is available! Talk to your **doctor** or other **addiction professional** about the **right treatment option** for you or the person you care about.

Medically assisted treatment with Buprenorphine, and/or Naltrexone is a relatively **safe, reliable** approach to reducing cravings, preventing high risk behavior, and **controlling opiate addiction**.

Addiction Services exist throughout **Vermont** and are organized according to a **“Hub & Spoke”** model in which the level of **treatment is tailored to the needs of the individual**.

“Hubs” offer more **intensive treatment and coordination** for those with more **difficult to treat addictions**. These centers are dedicated solely to the treatment of substance abuse and addiction.

“Spokes” offer **less intensive treatment and coordination of care** for individuals with **more stable addictions**. This type of site may include the office of your **Primary Care Provider**.
